## LINCOLN DAY GUEST GUIDANCE

### ARRIVAL INSTRUCTIONS

**Gates Open for Guests: 5:30 pm**

**Personal Vehicles:**

- Prior to entering Mar-a-Lago, please go through a Security Check at the Bath & Tennis Club parking lot and have your IDs and QR codes ready.
- Security will place a sticker on your windshield to grant entry to Mar-a-Lago.
- Enter the property via the Main Gate on South Ocean Blvd.
- Utilize the Club's valet service to park your vehicle.

**Rideshare:**

Please be advised that Uber, Lyft and any other rideshares are not allowed at The Mar-a-Lago Club. If you are utilizing a rideshare service please adhere to the following policy:

- Upon arrival, instruct drivers to drop off at the Main Gate on South Ocean Blvd. and have your IDs and QR codes ready. Guests will walk to Event Registration.

### SECURITY REQUIREMENTS

- The Mar-a-Lago Club utilizes a QR code based system for guest check-in. All guests must provide their first and last name, mobile phone number and/or email to the event organizer 72 hours prior to the event to receive a QR code for entry.
- All guests must present a valid driver's license, military ID, or US passport upon arrival.
- Any discrepancy between the name on the guest list and the name on your government-issued ID will delay the entry process.

### DEPARTURE INSTRUCTIONS

**Personal Vehicles:**

- Please pick up your vehicle at the Valet by the Ballroom Circle.

**Ride Share:**

- Instruct drivers to pick up at the white gate on Southern Boulevard. Guests will walk to the gate.

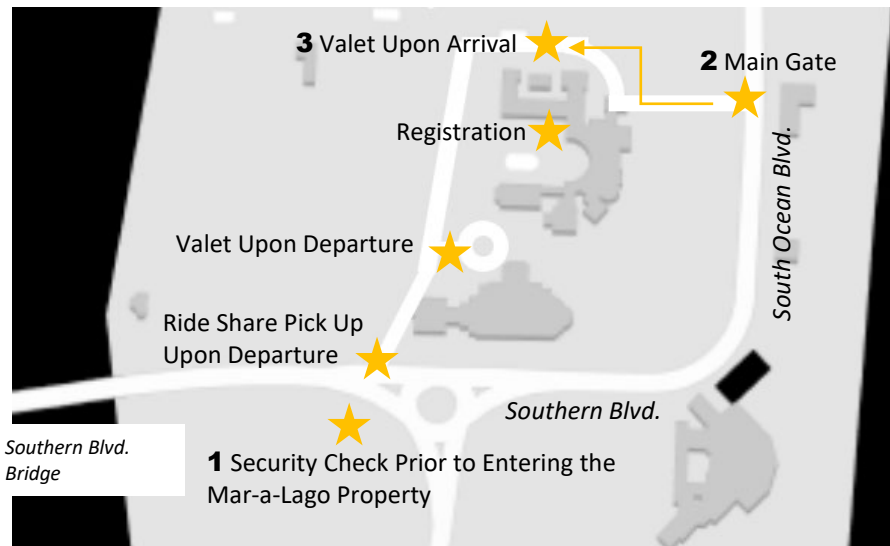
